## KEEP MORE OF WHAT YOU EARN WITH THE EARNED INCOME TAX CREDIT

The Earned Income Tax Credit (EITC) is a refundable federal income tax credit for low income working individuals and families. When EITC exceeds the amount of taxes allowed, it results in a tax refund to those who claim and qualify for the credit. The maximum credit allowed is \$6,242.

Taxpayers must file as single, married filed jointly, or head of household to qualify (not married filing separately). The credit is phased out at income levels of about \$54,000.

To qualify, you must file a tax return—even if you did not earn enough money to be obligated to file a tax return.



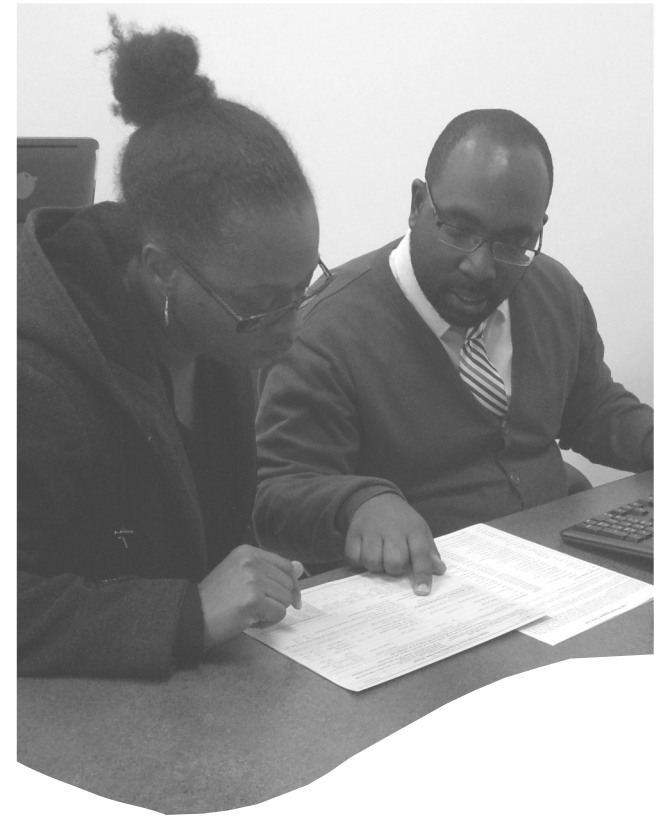

## WHAT CAN A FREE TAX PREP SITE DO FOR YOU?

- Complete your federal return and file it electronically
- Submit Schedules A and B (interest income and itemized deductions), child tax credit, child care credit, education credits, and EIC (Earned Income Credits)
- Prepare and file your North Carolina tax forms electronically
- CANNOT (for liability reasons) file Schedule C with losses

The following items are required. If items are missing, your tax return cannot be completed.

- Picture ID
- Social Security Card (or individual tax identification number) for yourself, and each dependent you are claiming, including spouse
- If filing jointly, spouse must be present
- W-2s and/or 1099s
- Employer ID numbers or SS numbers of childcare providers
- Last year's tax return, if itemizing
- Checking or savings account information if you want direct deposit of any refund
- Form 1095 A (if healthcare coverage is through the Marketplace, ACA (Exchange))
